PRESENTATION

Since 2013, the Public Law Department of Social and Human's Sciences School (FCHS) of Universidade Estadual Paulista "Júlio de Mesquita Filho" (UNESP) – Franca's Campus – SP carries out, annually, the "Seminar on State's Law". This year, the Seminar became international, with the presence of foreign lecturers and disclosure of the call through all South America. The chosen theme for this edition – "Globalization and the Grounds of Citizenship" – will allow the debate over relevant contemporary issues on the areas of Law and Social Sciences in general. CRITERIA ON THE SELECTION OF PAPERS TO BE PRESENTED ON THE ORAL COMUNICATION MODALITY

1. Deadlines

- Limit date to send the proposals (abstracts): 07/31/2016
- Limit date for disclosure of accepted papers: 08/31/2016
- Limit date to send the whole paper and autorization to public in the annais: 10/30/2016
- Limit date to subscribe as listener: 11/11/2016 (will be confirmed accordingly to the number of vacancy).

2. Rules for presentation of papers' abstracts

The papers' abstracts must have up to 2 pages, exclusivly in *PDF* format and with no authorship identification, with up and left margins of 3 cm and bottom and right margins of 2cm, font *Times New Roman* size 12, paragraph spacing 1,5, with quotes accordingly to the rules of ABNT, on the "author-data" system, and have the following elements: a) title; b) chosen theme axis; c) research issue lining; d) justification; e) goals; f) research method; g) synthesis of the obtained results. Abstracts that don't follow these rules won't be accepted. Portuguese, Spanish and English proposals will be accepted. On the e-mail text, there must be: a) full name; b) title; c) original institution; d) institution that finances the research (if there is one); e) researcher's address, phone number and eletronic address.

The abstracts must be sent exclusivly to: seminariodireitodoestado@hotmail.com, with the subject "abstracts".

3. Theme axis

- (1) Globalization, global governance and democracy
- (2) Globalization, citizenship and public policies
- (3) Globalization, constitutional jurisdiction and the guardianship and efectiveness of citizenship rights
- (4) Globalization, human rights and citizenship in the perspective of university extension

4. Candidates and authorship conditions

- Are allowed to send papers students regularly subscribed in grad, post-grad, masters and doctorate Law courses and other areas in Social Sciences. Are also

able to send teachers, researchers and professionals whose work and studies are related to the theme axis of the Seminar.

- The connection with the proposed themes is essential, in such a way that the failure in fulfilling this requirement blocks the abstract's approval.
- The papers might have up to 3 (three) co-authors.
- Each candidate can submit up to 2 (two) papers, as long as they are destined to the same theme axis.

5. Abstract's evaluation criteria

The papers will be selected through a blind evaluation made by 2 (two) analysts *ad hoc*, considering the following criteria: a) theme suitability to the IV Seminar on State's Law; b) relevance and delimitation of the investigation subject; c) method suitability to the problem investigation; d) theoric basis and bibliography; e) advanced stage of research development; f) coherence, cohesion and suitability of the presented text to the rules of the Portuguese Language (or Spanish or English, according to the case).

There will be no appeal on the decisions about admission or rejection and approval or rejection of the abstracts and presentation papers. The Judging Comission saves itself the right of solving negligent cases and creating or complementing the rules above accordingly to the most appropriate criteria to promote the best scientific results of the Seminar.

6. Subscribal fee

The recieval of papers' subscribal is conditioned to the payment of a subscribal fee in the designed deadline to send the abstracts, which shall be colected accordingly to the instructions available on the *link* of the IV State Law Seminar on the *website* of the Social and Human's Sciences School (FCHS) from UNESP/Franca's Campus – SP (www.franca.unesp.br).

The prices of the subscribal are as following: a) R\$ 80,00 (eighty reais) per author for post-grad papers; b) R\$ 50,00 (fifty reais) per author for grad papers; c) R\$ 30,00 (thirty reais) for listeners. There will be no devolution of subscribal fees.

Researchers benefited by any program of "student aid" will have a 50% discount on the subscribal fee for paper's presentation and are free for participation as listeners (until the limit of 30% of exempts from the total vacancy available for listeners).

7. Rules for full papers' presentations

The full papers must have between 10 and 15 pages, exclusively in *PDF* format, with up and left margins of 3 cm and bottom and right margins of 2 cm, font *Times New Roman* size 12, paragraph spacing 1,5, with quotes accordingly to the ABNT rules, in the "author-data" system, and have the following elements:a) title; b) research institution and researcher's data; c) introduction, with delimitation of the research problem, justification, goals and method; d) development; e) conclusion; f) bibliographic references and effectivly used sources. Full papers that aren't addapted to these rules won't be published on the "IV Seminar on State's Law's Annais". The

full papers must be sent exclusivly to the e-mail <u>seminariodireitodoestado@hotmail.com</u>, with the subject "papers". One highlights that the full papers – revised by the authors after oral communications and debates – will be published on the IV Seminar on State's Law's Annais.

8. Guidance on the oral communications

The oral communications sessions will occur accordingly to the program, location and time to be defined by the Organizing Commision, after confirmation of the receiving of the full papers, inside the predicted moments for this program activity. The papers will be divided by their level (grad or post-grad) and theme axis, being located, inside each axis, according to the affinity of the problems researched. The oral communications sessions will privilege, above all, the debate between the exposer and the present public, in a way that the time for individual presentations (fifteen minutes) will be precisely limited and controlled by the moderator.
