The PPSY welcomes all original contributions relevant to political science and its subdisciplines: comparative politics, international relations, development studies, security studies, public policy & governance, Polish and Central European politics, political theory & philosophy, political and electoral systems, as well as political communication. It also encourages Authors to present papers based on innovative approaches, and inter- or transdisciplinary investigations of political processes and institutions.

It implements the highest standards of academic journals and it continues to follow an aspiration to become influential international periodical presenting valuable contributions to political science.

## POLISH POLITICAL SCIENCE YEARBOOK: SPECIAL SECTIONS (2017)

In 2017 the PPSY invites Authors to contribute to **special sections**:

- "The Challenges of Security in Central Europe" (deadline for submission: February 15, 2017),
- "Politics of International Trade and Investments" (deadline: April 30, 2017)
- and "Politics of Post-Totalitarian Trauma" (deadline: August 31, 2017).

The first section discusses state of Central European cooperation in the field of security, regional and national security strategies, changing roles of the NATO and the United States in Central Europe, changes in Russian policy towards the region, involvement of Central European nations in the war on terror, as well as new challenges for regional security in the 21st Century. It is planned to be published in the first issue of the Volume 46 (May-June).



The second section encourages scholars to analyse changing landscape of international trade after the global economic crisis, new infrastructure for international investments and a global shift to the Pacific, impact of politics on perspectives for international entrepreneurship, national political strategies to support international economic development, a place of Central Europe in the global landscape of international trade, as well as politics of investment in Central Europe and Central European investments in the World. It is planned to be published in the second issue of the Volume 46 (November-December).

The third section develops investigations on national ways to deal with the totalitarian past, strategies to overcome legacies of totalitarianism and human rights violations, remembering vs. forgetting as political strategies of identity-reconstruction, contents of post-totalitarian remembrance narrative in a comparative perspective, post-totalitarian landscapes of memory, as well as legacies of totalitarianism in Central Europe and Post-Soviet area.
