**Giulia Vicentini** is Assistant Professor in Political Science and Public Policy at the University of Napoli Parthenope. She holds a PhD in Comparative Politics at the University of Siena and post doc positions at the Universities of Trento, Scuola Normale Superiore, Bologna and Padova. Her research interest range between party politics, candidate and leadership selection, elite studies, higher education policies, sustainable development, and energy policies. She worked as project manager and research assistant for the EU COST project PROSEPS (Professionalization and Social Impact of European Political Science).

**Gabriella Ilonszki** is Professor at Budapest's Corvinus University. Her field of interest is comparative politics focusing on Central and Eastern Europe. She has published extensively on parliaments, parties and elites in more than ten books and in several dozens of research articles.

He is one of the coordinators of the Research Group on "History of Political Science" of the *Asociación Latinoamericana de Ciencia Política* (ALACIP).

**Nelson Cardozo** has a Master's degree in Public Administration (UBA). Lecturer and researcher at the Universidad Argentina de la Empresa (UADE) and the Universidad de Buenos Aires (UBA). His topics of interest are pension reforms in Latin America; development, methodologies, theories, and teaching of public policies in the region. Co-chair of the Comparative Public Policy Research Committee (GIPPC) of the Latin American Association of Political Science (ALACIP).

**Emily Hauptmann** is Professor of Political Science at Western Michigan University. Her research focuses on the effects of private and public funding on what political scientists study and how they study it.

Her thesis, which dealt with gender inequalities in the institutionalization of Political Science in Brazil, received the prize for the best thesis defended at IESP-UERJ in 2021. The work was also a finalist in the ANPOCS thesis contest, which evaluates all postgraduate research defended in Brazil in Social Sciences.

**Mehtap Söyler** is Associate Professor at Izmir Katip Celebi University. She has a Ph.D. in Political Science from the Berlin Graduate School of Social Sciences at Humboldt University of Berlin. Her book "The Turkish Deep State" focuses on case study method and theory generation. Her research interests are social science methodology, democratization, civil-military relations, political institutions, and political science as a discipline.
